UNITED STATES OF AMERICA--STATE OF CALIFORNIA.

To all to whom these Presents shall come, Greeting:

Whereas, Under the provisions of an Act of Congress of the United States, approved the twenty-eighth day of September, A. D. one thousand eight hundred and fifty, entitled "An Act to enable the State of Arkansas, and other States, to reclaim Swamp Land within their limits," in which Act the manner of selecting and setting apart Swamp and Overflowed Lands is fully set forth; And Whereas, The Legislature of the State of California has provided for the Sale and Conveyance of said Lands by Statutes enacted from time to time; And Whereas, It appears by the Certificate of the Register of the State Land Office, Number 2044, bearing date May Twenty fifth, A. D. one thousand eight hundred and Sixty Nine, and issued in accordance with the provisions of law, that the tracts of **SWAMP AND OVERFLOWED LANDS** hereinafter described have been duly and properly surveyed in accordance with law; that full payment has been made to the State for the same, and that C. W. A. Arons is entitled to receive a patent therefor; said lands being situated in Sutter County, and described as follows, to wit: Survey No. 405 Swamp and Overflowed Lands, Sutter County, Township No. 11 North Range No. 3 East of Mount Diablo Meridian; Section No. 2nd & 3 being the NE 1/4 of Section (3) the NW 1/4 and the SW 1/4 of Section (2) and more particularly described in the field notes of said survey as follows:

The North East quarter 1/4 of Section (3); The North half and the South West quarter of Section (2) in Township No. (11) North Range (3) East of Mount Diablo Meridian, Containing Six hundred and forty 40 Acres.

Now, therefore, All the requirements of the Act of Congress, as well as the Acts of the State Legislature, in relation to Swamp and Overflowed Lands, having been fully complied with, I H. H. Haight Governor of the State of California, by virtue of authority in me vested, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto C. W. A. Arons all the above described lands, with the appurtenances thereunto belonging, to have and to hold, unto him the said C. W. A. Arons his heirs and assigns forever.

In Testimony Whereof, I H. H. Haight Governor of the State of California, have caused these Letters to be made Patent, and the Seal of the State of California to be hereunto affixed.
